*In addition to complying with the quality specifications set forth in Item No. 25 (Specifications as to Quality Received) in Bridger's F.E.R.C. No. 26.8.0 and subsequent reissues thereof, all petroleum movements from North House Creek Truck Stations, Savageton Truck Station, Hwy 59 Truck Station, and Fields Served by Gathering Segments in Campbell County, Wyoming to Belle Fourche Pipeline Black Butte in Campbell County, Wyoming must have (1) an API gravity of thirty-six (36) degrees or greater, and (2) less than 0.30% sulfur by weight.

NOTES:

Where a gathering service is performed by Bridger Pipeline LLC at the Fields Served by Gathering Segments in Campbell County, WY, a gathering charge of [D] 44.94 cents per barrel will be made in addition to the transportation rates named herein.
