No. 26.19.0 and subsequent reissues thereof, all petroleum movements from [N] ~~North House Creek Unit~~, North House Creek Truck Stations, [C] ~~Savageton Truck Station~~, Hwy 59 Truck Station, and Fields Served by Gathering Segments in Campbell County, Wyoming [C] ~~to Belle Fourche Pipeline Black Butte in Campbell County, Wyoming~~ must have (1) an API gravity of thirty-six (36) degrees or greater, and (2) less than [W] ~~0.20%~~ 0.30% sulfur by weight.

Where a gathering service is performed by Bridger Pipeline LLC at the Fields Served by Gathering Segments in Campbell County, WY, a gathering charge of [U] 55.36 cents per barrel will be made in addition to the transportation rates named herein.
