Bridger – pumpover movement from Eighty Eight Oil Johnson’s Corner Terminal (JCT), McKenzie County, ND to Bridger’s Fours Bears Pipeline system in McKenzie County, ND (Bridger F.E.R.C. No. [W] ~~36.33.0~~ ~~36.32.0~~). No gathering service will be performed in association with the joint movement covered under this tariff.

**Pipeline Loss Allowance**

Each shipper moving under this Joint Tariff shall be subject to a single pipeline loss allowance of 0.20% for movements hereunder.
