Note 2: The Tier 2 incentive rate set forth in Table 1 above will apply to movements from the indicated origin point to the indicated destination point by Shippers that qualify for the Tier 2 volume incentive program set forth in Note 8 of F.E.R.C. No. [W] 115.41.0 ~~115.40.0~~ or subsequent reissues thereof.

Note 3: Rates apply to crude petroleum delivered into Bridger Guernsey HUB.

*In addition to complying with the quality specifications set forth in Item No. 15 (Specifications as to Quality Received) in Bridger's F.E.R.C. No. [W] 112.32.0 ~~112.30.0~~ and subsequent reissues thereof, all petroleum movements from Hwy 59 Truck Station, North House Creek Truck Station, and Triangle U Truck Station in Campbell County, Wyoming must have (1) an API gravity of thirty-six (36) degrees or greater, and (2) less than 0.20% sulfur by weight.

Additional charges are applicable for movements beyond Guernsey Station and to connecting carriers per Bridger's F.E.R.C. No. [W] 129.15.0 ~~129.13.0~~ and subsequent reissues thereof.
