Note 1: See Bridger Pipeline LLC's F.E.R.C. No. **[W]** <u>569.27.0</u> 569.25.0 and subsequent reissues thereof for the transportation rates applicable to movements on Bridger's pipeline system that deliver into Bridger Guernsey HUB, Platte County, Wyoming.

Note 2: Eighty-Eight Oil LLC delivers Petroleum to Bridger Guernsey HUB, Platte County, Wyoming from Eighty-Eight Oil LLC's Guernsey Station, Platte County, Wyoming.

Note 3: Plains Pipeline, L.P. is an upstream connecting carrier that delivers into Bridger Guernsey HUB, Platte County, Wyoming.

Note 4: See Bridger's F.E.R.C. No. **[W]** <u>119.21.0</u> 119.20.0 and subsequent reissues thereof for the transportation rates applicable to movements on Bridger's Thunderbird line that deliver into Bridger Guernsey HUB, Platte County, Wyoming.

Note 5: See Bridger's F.E.R.C. Nos. **[W]** <u>115.41.0, 125.23.0, 126.17.0, and 128.27.0</u> 115.40.0, 125.22.0, 126.16.0, and 128.26.0 and subsequent reissues thereof for the transportation rates applicable to movements on Bridger's Powder River Basin line that deliver into Bridger Guernsey HUB, Platte County, Wyoming.

Note 6: Platte Pipe Line Company, LLC is an upstream connecting carrier that delivers into Bridger Guernsey HUB, Platte County, Wyoming.

Note 7: A transfer fee of **[I]** <u>13.26</u> cents per barrel will apply in addition to the rate set forth in the Table of Rates above to any movements from the West Terminal Meter, Wyoming to the Bridger Guernsey HUB, Platte County, Wyoming. No additional pipeline loss allowance will be charged for this transfer movement.

Note 8: As of February 1, 2024, Bridger will no longer accept Crude Petroleum with a viscosity greater than 30 Centistokes (cSt) for transportation to the noted destinations.

Pipeline Loss Allowance

The 0.2% volume correction for evaporation and loss during transportation, as provided in Item No. 30 of Bridger's F.E.R.C. No. **[W]** <u>112.32.0</u> <u>112.31.0</u> and subsequent reissues thereof, does not apply to movements under this tariff. Rather, any movements contemplated under this tariff will be subject to a volume correction of 0.1% for evaporation and loss during transportation.
